

## **EFI Connect 2019 Conference “Visit Our Sponsors” Sweepstakes OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

**SPONSOR.** Electronics For Imaging, Inc., 6750 Dumbarton Circle, Fremont, CA 94555 ("Sponsor").

**AGREEMENT TO OFFICIAL RULES.** By participating in the EFI Connect 2019 Conference “Visit Our Sponsors” Sweepstakes (“Sweepstakes”), you fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.

**ELIGIBILITY.** The Sweepstakes is open only to legal residents of the 50 United States or the District of Columbia (excluding Puerto Rico and all other territories and possessions of the United States) who have registered to attend the EFI Connect 2019 Conference and provided their name and contact information on a completed entry submission. The entering participant must be 18 years of age or older as of the commencement of the Sweepstakes. The Sweepstakes commences on January 22, 2019 at 2:00 p.m. (Pacific Time) and ends on January 25, 2019 at 1:00 p.m. (Pacific Time). Employees of Sponsor and its affiliates, subsidiaries, advertising or promotional agencies, their immediate family (e.g., spouses, parents, siblings, children), and persons living in the same household of any of the above employees are ineligible. Sponsor and affiliates, subsidiaries, employees, directors, officers, agents, assigns, and licensees (collectively, “Entities”) are not responsible for late, lost, damaged, illegible or incomplete entries. Limit one entry per drawing per EFI Connect 2018 Conference registrant. Sweepstakes entrant must be present to win. Sponsor reserves the right to change the Sweepstakes rules at any time in its sole discretion, and retains the right of final decision in all matters pertaining to the Sweepstakes. Due to unforeseen circumstances that can arise from time to time, Sponsor, in its sole discretion, reserves the right to terminate the Sweepstakes at any time. The Sweepstakes is void outside the 50 United States and the District of Columbia and where prohibited or restricted by law. The Sweepstakes is subject to all applicable federal, state and local laws and regulations.

**ENTRY.** Complete an EFI Connect 2019 Conference Passport card by collecting a sticker from each of the EFI Connect 2019 Conference sponsors indicated on the Passport card and placing the corresponding

sticker from each sponsor in its designated position on the Passport card. Submit a completed EFI Connect 2019 Conference Passport card to the EFI Connect 2019 Conference Registration station 2 (or another location designated by Sponsor in its discretion) by 1 p.m. (Pacific Time) on Friday, January 25, 2019 to be entered into the Sweepstakes. You will receive one Sweepstakes entry for each eligible submission. You may also enter by mailing a

All entries must be received by Sponsor no later than 5 p.m. (Pacific Time) on January 15, 2019 for the drawing on January 26, 2019. All other forms of entry not specified herein are void. Incomplete, duplicate, mechanically or electronically reproduced, and/or automated entries are not permitted and will be deemed void. Limit one entry per eligible submission as specified above, regardless of the method of entry. Entries become Sponsors' property and will not be returned.

**PRIZES.** The following prizes will be awarded: one (1) prize of reimbursing up to three (3) nights lodging at the Wynn hotel during the EFI Connect 2020 Conference or a \$400 credit toward the EFI Connect 2020 Conference registration fee, to be determined by Sponsor in its sole discretion; one (1) prize of reimbursing up to two (2) nights lodging at the Wynn hotel during the EFI Connect 2020 Conference or a \$250 credit toward the EFI Connect 2020 Conference registration fee, to be determined by Sponsor in its sole discretion; and one (1) prize of reimbursing up to one (1) night lodging at the Wynn hotel during the EFI Connect 2020 Conference or a \$125 credit toward the EFI Connect 2020 Conference registration fee, to be determined by Sponsor in its sole discretion. : The approximate total retail value of all the prizes will not exceed \$1236.00. All prize amounts are in U.S. dollars.

Certain restrictions apply. Each winner is responsible for paying all other costs and expenses related to the prize. Potential winners will be notified by e-mail and/or regular mail within ten (10) business days of the drawing and will have ten (10) calendar days after notification to claim the prize. The winner may be disqualified and the winner's prize forfeited upon the occurrence of any of the following: (i) the failure of winner to confirm winner's eligibility; (ii) the failure of winner to return any required documents by the deadline specified by Sponsor, including an Affidavit of Eligibility and Release as specified below; (iii) the return of the prize notification to Sponsor as undeliverable; (iv) the failure of the winner to claim the prize within the period described above; or (v) the determination by Sponsor that winner is ineligible or otherwise not in compliance with these official rules.
